

Notification of the Ministry of Natural Resources and Environment
on Projects, Undertakings, or Operations Required to Provide an Environmental Impact
Assessment Report and Rules, Procedure, and Conditions in Providing
an Environmental Impact Assessment Report
(No.2) B.E. 2562

As it is appropriate to amend how to specify types of projects, undertakings, or operations under the Notification of the Ministry of Natural Resources and Environment on Projects, Undertakings, or Operations Required to Provide an Environmental Impact Assessment Report and Rules, Procedure, and Conditions in Providing an Environmental Impact Assessment Report dated 19 November B.E. 2561,

Under the power of Sections 48 of the Enhancement and Conservation of National Environmental Quality Act B.E. 2535 as amended by the Enhancement and Conservation of National Environmental Quality Act (No. 2) B.E. 2561, the Minister of Natural Resources and Environment, with the National Environmental Board's approval, notifies the followings herewith:

No. 1: The following definition text shall be added after the definition of "onshore natural gas pipeline transportation system" under No. 2 of the Notification of the Ministry of Natural Resources and Environment on Projects, Undertakings, or Operations Required to Provide an Environmental Impact Assessment Report and Rules, Procedure, and Conditions in Providing an Environmental Impact Assessment Report dated 19 November B.E. 2561:

"community development and land arrangement" means a project that places importance on community development and land arrangement for people to live together with the forests by balancing taking benefits from and nurturing the nature.

No. 2: The texts in No. 22, 26, and 33 under Annex 4: Projects, Undertakings, or Operations Required to Provide an Environmental Impact Assessment Report of the Notification of the Ministry of Natural Resources and Environment on Projects, Undertakings, or Operations Required to Provide an Environmental Impact Assessment Report and Rules, Procedure, and Conditions in Providing an Environmental Impact Assessment Report dated 19 November B.E. 2561, shall be revoked and replaced by the followings:
