As it is appropriate to amend how to specify types of projects, undertakings, or operations pursuant to Notification of the Ministry of Natural Resources and Environment on Projects, Undertakings, or Operations Required to Provide an Environmental Impact Assessment Report and Rules, Procedure, and Conditions in Providing an Environmental Impact Assessment Report dated 19 November B.E. 2561 to be more proper,
